### Call for Submissions for 2023 FEO Excellence Award

Dear Presidents and Delegates,

On behalf of the European Federation of Orthodontics, I am sending you notice of the FEO Excellence Award. The board of FEO invite societies to make their candidate proposition by **16<sup>th</sup> September 2022** please.

### FEO EXCELLENCE AWARD

The FEO Excellence Award was established in 2020 by action of the FEO Council following an amendment in the FEO Internal rules. It was approved at the Athens FEO General Assembly Meeting of 6th Dec 2020 and this will be it's second presentation following the inaugural award to Professor Nigel Hunt of the UK in 2021.

The FEO Excellence Award is offered every second year to members who are registered orthodontists of an affiliated or corresponding society that have significantly contributed to the progress of orthodontics in Europe.

1. The Board will call upon nominations every second year.
2. FEO Secretary General will send a letter calling for nominations, stating the deadline.
3. A FEO affiliated society in good standing is eligible to submit a nomination to the FEO Excellence Award. Each nominator is limited to one FEO Excellence Award nomination.
4. To make a nomination the following is required:
  - a. Curriculum vitae
  - b. Short resume of the contribution to the progress of orthodontics in Europe
  - c. Letter of nomination and support signed by the president of the national orthodontic society, member of the FEO.

### Criteria for nomination:

The Nominee must:

1. be an orthodontist.
2. have made significant contributions to the science related to the specialty of orthodontics through research in Europe.
3. have made a significant humanitarian contribution as a clinical orthodontist.
4. have established an academic legacy, inspiring young generations in the specialty of orthodontics through teaching and research

### Call for Submissions for 2023 FEO Excellence Award (cont.)

#### Awards Committee

1. The Board of FEO and the FEO Advisory Committee comprise the Awards Committee
2. The Awards Committee's decision will be final

#### General Awards Process

1. Each nomination can be accepted or rejected.
2. If accepted each nominee will be examined and voted in one of the 3 appropriate categories (See criteria for nomination point 2, 3 and 4).
3. If rejected the nomination cannot be presented again.
4. A majority vote is necessary in the award committee for the final selection among the 3 categories.
5. The final decision is communicated to the national societies.
6. The award is assigned at the following FEO session and GAM.
7. The award recipient shall be invited to attend as a Keynote speaker at the award ceremony to be held during the following FEO session and GAM, with meeting registration and travel contribution of €500.
