### APPLICATION PROTOCOL:

#### FEO Award and FEO Best Clinical Paper Award

#### PROTOCOL FOR SUBMISSION

1. The President or nominated person of FEO affiliated Societies will be asked to select their submission for the best article published in the official Journal of their Orthodontic Society. Personal submissions are not accepted.
2. The article must be original.
3. The article must have been published in the journal within the two years preceding the Award.
4. At least one of the authors must be a member of a FEO affiliated National Orthodontic Society.
5. The FEO Secretary-General must receive the articles no later than the published closing date.
6. No late submissions will be accepted.
7. If the articles are not published in English they must be accompanied with an authenticated English translation. The FEO may offer a translation service, where this is not available locally, paid for by FEO.
8. The selected papers will be anonymised before submission to the Award Committee.
9. Awards will only be paid if the winning author presents their paper at the congress meeting where the award will be presented.

#### AWARDS COMMITTEE

1. The Board of FEO including the three FEO Past-Presidents comprise the Award Committee.
2. The Award Committee's decision will be final.

#### SELECTION WILL BE BASED UPON

1. The scope of nominee's research, with special emphasis being placed on its impact on orthodontics.
2. The implication of the results on clinical applications.

#### WINNERS

1. The winning author will receive an award of 1000 euro and a further single payment of 500 euro will be offered to the presenting author(s) towards covering some of their travelling expenses to make their presentation.
2. Awards will only be paid if the author presents their paper at the designated congress meeting.
